Postgraduate Seminar in Urban Anthropology 城市人类学

More than half of the world's population now lives in cities. Rapid urbanisation undoubtedly bears many of opportunities, but also a great deal of problems and challenges. The goal of this course is to introduce how anthropology, a discipline traditionally associated with rural settings, can contribute to our understandings of contemporary urban phenomena. We use anthropological insights and methods to engage the city theoretically and empirically. We focus on the changing nature of urban social life, urban space and place, urban governance and planning, cities as socio-technological laboratories for future living and, more generally, on what may constitute a city in the context of global flows and interconnections. This course explicitly makes the urban the context *and* object of study. Some of the questions that we discuss include: How do cities shape identities and social relations? What kinds of socio-cultural phenomena emerge in complex urban contexts often characterised by anonymity, diversity and inequality? How are groups and institutions both shaping and shaped by urban space? How do urban settings configure the negotiations and power relations between and among different groups and institutions? What kinds of technological advancements do cities necessitate and how, in turn, may they transform cities and urban life in the future?

世界人口的一半以上现在生活在城市里。快速城市化无疑带来许多机遇,但也带来许 多问题和挑战。这门课程的目的是介绍人类学,一门传统上被视为与农村环境和社会 相关的学科,如何有助于我们理解当代城市的多种现象。这门课程运用人类学的见解 和方法,从理论和经验上探讨城市与城市化。我们侧重于城市社会生活的不断变化的 性质、城市空间和场所、城市治理和规划、城市作为未来生活的社会技术实验室,以 及更广泛地说,在全球流动和相互联系的背景下,如何去理解和定义"城市"。这门 课程不仅把城市作为研究的背景而也把它作为研究的对象。我们讨论的一些问题包 括:城市如何塑造身份和社会关系?在互不相识、多样性和不平等为特征的复杂城市 环境中,会出现什么样的社会文化现象?城市空间是如何塑造群体和机构的?反过来, 群体和机构又如何塑造城市空间?城市如何设置不同群体和机构之间的反复碰撞和权 力关系?城市需要什么样的技术进步?反过来,它们又如何改变城市和未来的城市生 活?

Learning outcomes: By taking this course, students will...

- 1. learn how to understand and study the city anthropologically.
- 2. acquire knowledge of different urban theories.
- 3. come to appreciate, but also critically reflect on the many ways in which humans shape and are shaped by cities.
- 4. gain a thorough understanding of contemporary urban problems.
- 5. be able to develop their own urban anthropological projects.

Participation:

You are expected to regularly attend and participate in class discussions. This is an ethnographic exercise, but you should also raise some points for discussion and reflection on what it says about the city or urban life.
